This agreement may be terminated by either party within 10 days written notice, or upon the expiration date of the credit card, or the failure of any payment to be processed, whichever occurs first. Any outstanding balance due on this rental may be charged to my credit card. In the event no further charges can be processed on my credit card, for any reason, I agree to be personally responsible to pay those charges to **US Van Rental** upon demand.
